**ACKNOWLEDGEMENT OF RULES AND PROCEDURES**

As a resident (whether owner or tenant) of Paseo Village Homeowners Association, I hereby acknowledge and affirm that I have been provided with a copy of the current Paseo Village Homeowners Association Rules and Regulations; that I will read and I understand the Rules and Regulations, and that I accept, honor and will abide by the provisions thereof. I have noted especially the provisions governing:

- 1. Vehicle parking policies and restrictions.
- 2. Pets must be kept totally within lots.

I understand that the maximum occupancy of any unit at Paseo Village Homeowners Association is five (5) people and that violation can result in fines and other enforcement initiatives.

I understand that each vehicle which belongs to a resident and which will be parked on Paseo Village Homeowners Association property on a regular basis (either parked inside or outside garages) must display a PVHA parking sticker and that the parking stickers are available from the Manager (8-D). Vehicles parked in violation of the Rules can be fined or towed away at the owner’s expense.

I understand that use of the pool and common areas is limited to residents and their guests and that pool passes or other means of control will be enforced by the Management.

I understand that my family and guests are required to abide by all PVHA Rules and Regulations and that it is my responsibility to ensure their compliance with these rules as set forth.

I understand that other residents are expected to respect my rights and to demonstrate the same courtesy to me according to the PVHA Rules and Regulations and that I am voluntarily agreeing to honor and abide by these rules and regulations.
